

**MORAVIA CITY COUNCIL
SPECIAL MEETING #1
TUESDAY, MARCH 26, 2024**

A special meeting of the Moravia City Council was called to order by Mayor Roy Miller at 4:30 PM on Tuesday, March 26, 2024, at Moravia City Hall. In addition to Mayor Miller, those present at the meeting were Councilpersons Ken Martin, Ron Deal, John Baty, and Sheila Kirby. Councilman Tom Kramka was absent. Sharla Stogdill, Mitch Main, and Sam Kirby were also present. The meeting opened with a prayer by Councilman Ken Martin and the Pledge of Allegiance. Mayor Miller welcomed the public.

Motion by Baty and seconded by Kirby to approve the agenda. Roll Call Vote: Deal-Aye, Martin-Aye, Kirby-Aye, Kramka-Absent, Baty-Aye. Motion carried.

Motion by Deal and seconded by Martin to open the public hearing for fiscal year 2024/2025 City of Moravia Proposed Property Tax Rate at 4:32 PM. Roll Call Vote: Deal-Aye, Martin-Aye, Kirby-Aye, Kramka-Absent, Baty-Aye. Motion carried. Clerk Stogdill reviewed with the Council the proposed tax rate of 12.27663. The increase in the tax rate is due to increased costs in property insurance, health insurance, and worker's compensation insurance. The City of Moravia's proposed tax rate is lower than five other towns in Appanoose County. Mayor Miller and Clerk Stogdill did not receive any questions or comments at City Hall regarding the proposed tax rate. There were no questions or comments from the public attending the public hearing. Motion by Martin and seconded by Baty to close the public hearing for fiscal year 2024/2025 City of Moravia Proposed Property Tax Rate at 4:37 PM. Roll Call Vote: Deal-Aye, Martin-Aye, Kirby-Aye, Kramka-Absent, Baty-Aye. Motion carried.

Roll Call Vote: Deal-Aye, Martin-Aye, Kirby-Aye, Kramka-Absent, Baty-Aye. Motion carried. Resolution approved and adopted.
