

**MORAVIA CITY COUNCIL  
SPECIAL MEETING #2  
TUESDAY, MARCH 26, 2024**

A special meeting of the Moravia City Council was called to order by Mayor Roy Miller at 4:45 PM on Tuesday, March 26, 2024, at Moravia City Hall. In addition to Mayor Miller, those present at the meeting were Councilpersons Ken Martin, Ron Deal, John Baty, and Sheila Kirby. Councilman Tom Kramka was absent. Sharla Stogdill, Mitch Main, and Sam Kirby were also present. The meeting opened with a prayer by Councilman Ken Martin and the Pledge of Allegiance. Mayor Miller welcomed the public.

Motion by Martin and seconded by Kirby to approve the agenda. Roll Call Vote: Deal-Aye, Martin-Aye, Kirby-Aye, Kramka-Absent, Baty-Aye. Motion carried.

Clerk Sharla Stogdill introduced Resolution 11-2024 – Resolution to Set Date, Time, and Location of Public Hearing for Fiscal Year 2024/2025 City Budget for Moravia, Iowa. Motion by Deal and seconded by Kirby to approve Resolution 11-2024 - Resolution to Set Date, Time, and Location of Public Hearing for Fiscal Year 2024/2025 City Budget as Tuesday, April 16, 2024, at 5:00 PM at Moravia City Hall. Roll Call Vote: Deal-Aye, Martin-Aye, Kirby-Aye, Kramka-Absent, Baty-Aye. Motion carried. Resolution approved and adopted.

The Order for Judgment for Case No. MOCIC10770 was reviewed and discussed.

Council Discussion Items – Councilwoman Kirby discussed a thirty-inch Moravia star that was donated by Margaret Richardson. She recommended installing it above the city's Moravia sign at Highway 5. Council agreed by consensus.

Councilman Martin inquired if an American flag could be hung on a wall in the council room. A map of city streets and a map of the cemetery was also discussed to be hung on the council room wall.

Maintenance Supervisor Mitch Main met with an engineer from ISG and a salesman from NitrOx. They toured Moravia's lagoon on March 26, 2024, and agree that the NitrOx system could be built there. The town of Hartford just finished installing a NitrOx system and Milo is in the process of installing one. Mitch and Mayor Miller will visit both facilities. Council requested the engineer and salesman attend the April 16 council meeting to explain the system to the Council. Discussion was held on Grade 2 operator pay and requirements.

Mayor Discussion Items – Mayor Miller received an e-mail from the railroad saying they will send us a contract this week. Mayor Miller inquired about increasing the price of reconnect fees when a water account is shut off for non-payment. Clerk Stogdill will check with the Iowa League of Cities on rules. If there are no rules or limits, an ordinance will be prepared for a first reading. Over sixty delinquent letters are sent to past due customers each month. The clerk is streamlining this process to make it less time consuming. Mayor Miller stated the city received the grant funds for the community building makeover and work has begun.

Motion by Martin and seconded by Kirby to adjourn the meeting at 5:28 PM. All Ayes. Motion carried.
