Department Reports were given:

Fire – Fire Chief Ryan Moore reported fourteen calls for October and a total of 122 calls for the year, which is higher than average. The EMS tax levy did pass by 73% in Appanoose County. Sixty percent was required for it to pass. Five other counties in lowa that had this on their ballot failed. The new secretary for the fire department is Ashley Snow. The fire department handed out candy to 172 children on Halloween. The department will be hosting grain bin rescue training on November 17. Other nearby departments have been invited to the training. The department had air bag and vehicle stabilization training in October. Five members attended a training conference in Des Moines and received CEU's for their attendance.

Library – Library Director Amanda Smith reviewed library activities with the Council. The Civil War reenactment was well attended with a total of 74 people including members of the Friends of the Library and reenactors. Patrons are taking advantage of the tech help at the library regularly. E-mail provider change is up and running. Paintings, photos, or drawings are needed for their art show fundraiser. Pickleball rackets have been received and a policy is being written for checking them out of the library. Santa and his elves will be at the library on December 7.

Cemetery - Flags at the cemetery looked nice for Veterans Day.

Parks – Several people are using the pickleball court and basketball court.

Streets – Councilman Kramka inquired about paving the gravel portion of Frontage Road. Council needs to prioritize projects. Councilman Baty inquired about cutting the edges of North East Street.

Water - Delinquent accounts were reviewed. There were three shut-offs in November for non-payment.

Sewer – Mitch has submitted the compliance update progress report to French-Reneker for review. The permit renewal required extra samples. The DNR sent a letter stating they have reviewed our updated construction Schedule G, design flows and loads and other documents for the Moravia Wastewater Treatment Improvements project and they are in agreement with the proposed flows and loads and the construction schedule G is authorized.

City Staff – City Clerk Stogdill gave council updated ordinances for their books at home. Financial reports were reviewed. The City is in excellent financial condition. The city received a notice from Alliant Energy of a fifteen percent increase in utility rates. Sharla will be attending an on-line budget training on December 5. Maintenance Supervisor Mitch Main reported losing an engine on another lawn mower. The council will need to budget to replace the mower. The city needs a snow plow for the new truck. Mitch reviewed two options and prices with the Council. Motion by Baty and seconded by

We will need to budget for a second sander in next year's budget. Maintenance Assistant Shaun Wubben will be starting on Christmas lights and decorations. Councilman Martin reported the Ruritans have disbanded and will not be putting up any Christmas lights.
