

**MORAVIA CITY COUNCIL
REGULAR MEETING
TUESDAY, FEBRUARY 10, 2026**

The regular meeting of the Moravia City Council was called to order by Mayor Roy Miller at 5:00 PM on Tuesday, February 10, 2026, at Moravia City Hall. In addition to Mayor Miller, those present at the meeting were Councilpersons Ken Martin, Tom Kramka, John Baty, Eric Wilson, and Sheila Kirby. Sharla Stogdill, Mitch Main, Shaun Wubben, Marcia Benjamin, Amanda Smith, Ryan Moore, and Jessi Moore were also present. The meeting opened with a prayer by Ken Martin and the Pledge of Allegiance. Mayor Miller welcomed the public.

Motion by Baty and seconded by Kirby to amend the agenda to add "Consider Approval of Liquor License for Fat Annie's" after public comments. Roll Call Vote: Kirby-Aye, Martin-Aye, Kramka-Aye, Wilson-Aye, Baty-Aye. Motion carried.

Comments from the public – None.

Mayor Miller checked with ADLM and the State of Iowa, as well as our code of ordinances, and the broken window above Fat Annie's would not be a reason to deny their liquor license. Department Reports were given:

Fire – Fire Chief Ryan Moore reported 17 calls for January. There was another ice incident the department responded to in January. During a large house fire, the department had issues with lines, nozzles, and valves freezing in the frigid temperatures. Four members attended state fire school. Jessi Moore attended a water safety course while there and ordered a fast board with lights and flotation. The department is looking at other ice rescue equipment. Four new members who are all Firefighter I certified were added to the Moravia Fire Department. They are also members of other departments. One more person has submitted their application to join. Ryan reported there is only two members on the county diving team, so they are training a new group of members to raise that number to ten or twelve. The American Red Cross has a smoke detector program where they are giving away free smoke detectors, and the Moravia Fire Department will install them for residents for free. If anyone wants one, please let them know so they order enough.

Library – Library Director Amanda Smith reported the Friends of the Library are applying for a grant through PACT to purchase a new desk for the library director and assistant. The Library Board of Trustees approved Sharon Hardy to fill a vacant board member position. Motion by Kramka and seconded by Baty to approve the appointment of Sharon Hardy to the Moravia Library Board. Roll Call Vote: Kirby-Aye, Martin-Aye, Kramka-Aye, Wilson-Aye, Baty-Aye. Motion carried. Updated job descriptions for the library director and assistant were approved by the Library Board. National Library Week is April 19-25. All board members need to complete 3-5 hours of continuing education on an annual basis.

Cemetery – Nothing to report.

Parks – Nothing to report.

Streets – Councilman Kramka stated the bump is still in the street by Teno's.

Water – Delinquent accounts were reviewed. No water was shut off for non-payment in February.

Sewer – Nothing to report.

City Staff – City Clerk/Treasurer Sharla Stogdill reviewed financial reports with the Council. She is continuing work on the city's budget and getting payroll deductions set up in ClerkBooks for dental insurance. Mitch Main has locates called in for new street signs. Reflectors have been put on the stop sign at Dollar General.

Resident Complaints – Nothing to report.

Nuisance Properties and Junk Vehicles – Mayor Miller reported the appealed nuisance property case has until February 21 to file their case with the Court of Appeals. The car has been moved that was parked illegally on East Charles Street. We do not know if the owner moved it or if Bratz towed it.

Council Discussion Items – Councilman Baty acknowledged the loss of Irene Brooks and how much she did for the town when she was Mayor. The Council appreciates all her hard work during a difficult time in the city.
